**Accreditation Committee Members Announced by the
Population Health Impact Institute:
*Work to Begin on Drafting Quality Evaluation ProcessSM (QEPSM) Standards***

October 25, 2007, Cincinnati – The Population Health Impact Institute (PHI) announces the formation of their Quality Evaluation Process (QEP) National Advisory Panel. The panel, made up of a Steering committee and a Standards committee, will develop standards for a program evaluation accreditation program. These “QEP standards” will focus on “the methods behind the claims” (monetary and clinical) of disease management, wellness, P4P, medical and case management, and other defined population health programs.

Thomas Wilson, PhD, DrPH, Founder and Board Chair of the 501(c)(3) non-profit organization, noted “the response to our recent announcement about the development of the QEP accreditation program has far exceeded our expectations. An impressive and balanced panel has been assembled and we are delighted that Garry Carneal, JD MA, a nationally recognized accreditation expert, will chair the Standards Committee, and Joel V. Brill, MD, a physician thought leader, will chair the Steering Committee.”

Dr. Brill noted “I am honored to help coordinate this project. Clearly, many see the need to establish a uniform set of standards around transparency of methods and scientific validity of methods used for ROI claims. The PHI is ideally suited to create an objective approach for apples-to-apples comparison of different, and often, competing methods and programs.”
